

Acquisition of a foreign optical module company



Overview

Semtech Corporation, a provider of high-performance semiconductors, Internet of Things (IoT) systems, and cloud connectivity service solutions, has acquired HieFo Corporation, a manufacturer of high-efficiency indium phosphide (InP) optoelectronic devices for \$34 million. Xi'an, China, September 2nd, 2024 – – Focuslight Technologies Inc. The United States stood out as the most active player, accounting for 58 deals. In Asia, Japan registered 9 acquisitions, followed by South Korea with 2, and Taiwan and Singapore with one each. Compounding these challenges are persistent supply chain disruptions and labor shortages, which have added layers of complexity for buyers and sellers alike. High interest rates, lower valuations, and geopolitical instability deter many buyers and sellers while. There remains uncertainty in the global M&A market as deal volume and total deal value recover from the record lows of 2023. M&A activity for targets employing photonics technology, however, appears to be on a steep upward trajectory in 2024.
